## **Excellence and Innovation Network for Health**



### **The idea:**

This is an idea to create an evidence for health program. The Network of Excellence and Innovation for Health is a network of non-profit voluntary initiated to help promote the concept of decision-making based on evidence and bring the changes necessary to reformulate the health system. The network will be based on the principle of "the best way to make the change happen would be through the collection with members of the community institutions that work for them."

### **Vision and objectives:**

The network will become a strong and important source to translate the knowledge and theoretical sciences and applied to the experiences and interesting projects in different areas of health and will contribute to the creation of a better health system, the members of the network will become a strong source for the dissemination of this culture and the model referred to. Therefore, the network aims in it is overall vision to the following:

1. The network will serve as an effective tool for the implementation of institutional change programs based on evidence from performing experiments.
2. Creation of cooperation and a close link between public and private sector institutions to ensure public benefit from their experiences in strengthening the health system.
3. Enrich the diversity and development of the areas of partnerships in various public health programs
4. Contribution to enrich the knowledge and experiences on public health programs and improve the utilization of public health resources and other resources and knowledge relating to evidence and proof.



## **Membership:**

### **What are the benefits of network membership?**

- We hope to membership in the network at this time volunteered two or one person at least from every organization



## **Future vision of the membership**

- the membership of the network will expand and there will be requirements to qualify for membership in the network of institutions and individuals in accordance with what the management of the network see in the future
- This component will be implemented over a period of between 9 to 12 months, then the experience will be evaluated and the lessons learned from it will be addressed for maximum utilization.
- This vision includes the expansion of all local, regional and international level and the network plans must be taken into account
